

Almost 6,000 MCOs attend 36th AGMA

Five Thousand Nine Hundred Ninety-Five (5,995) Member-Consumer-Owners (MCOs) attended the 36th Annual General Membership Assembly (AGMA) comprising of members of the Multi-Sectoral Electrification Advisory Council (MSEAC), participating prompt payers and MCOs together with the CAGELCO II Board and employees bearing the theme, "Achieving Greater Synergy on the Road to Operational Excellence."

The 1st leg of the Annual General Membership Assembly (AGMA) was held at Isabel Arellano Antiporda Gymnasium, Buguey, Cagayan last May 21, 2017 with Senator Sherwin "Win" T. Gatchalian as Guest of Honor & Speaker. However, due to unfavorable weather condition, he was unable to make it to the occasion. He, however, delivered a message for the MCOs through a video expressing his support to the Rural Electrification Program in this part of the country.

The final leg of the event was held at Pamplona Cultural and Sports Center, Pamplona, Cagayan last May 27, 2017. Local dignitaries were present to include the Vice Governor of Cagayan, Hon. Melvin K. Vargas, Jr. as the Guest of Honor & Speaker and Hon. Arnie Angelica P. Sampaga, MD, Mayor of Pamplona, who welcomed the delegates from the Municipalities of Abulug, Ballesteros, Sanchez Mira, Claveria, Sta.

CAGELCO II through its Human Resource Division conducted a re-echo seminar on Basic Occupational Safety and Health (BOSH) for all its 189 employees to instill the importance of safety and protection in the workplace held last June 01, 02, 08, 09, and 16 at CAGELCO II Multi-Purpose Hall, Aparri, Cagayan.

Ms. Blandina Y. Madamba, OIC-General Manager initiated the conduct of the seminar and pointed out that the workforce of the organization must be built with a strong drive of self-importance as he/she is a valuable entity not only in the organization but in the community.

During the seminar, it was emphasized that work-related accidents and diseases can be prevented when an employee follows the standard or written job procedure or common practice, safety rules and regulations, or instructions. The malpractice of the safety

Moreover, the symposium informed the employees of the proper handling of different types of machines and equipment such as fire extinguisher, electrical tools, and vehicles. Further, the body was reminded of the use of Personal Protective Equipment (PPE) which is vital especially to the field workers.

The activity was spearheaded by Engr. Elmer P. Francisco, Engineering Division Chief of CAGELCO II who was also one of the speakers together with the other members of the committee namely Engr. Crisente Laddaran, Engr. Nathaniel Reyes, Engr. Mark Guzman, Engr. Ericson Pasion, Engr. Algeron Orquia, Engr. Herald Unciano, Mr. Raymond Ogalino, Mr. Regie Tabisaura, and Ms. Mae Rabanal.

Various topics were discussed which included Occupational Safety and Health; Unsafe & Unhealthy Acts and Conditions; Workplace Good Housekeeping; Material Handling and Storage; Fire Safety; Electrical Safety; Machine Safety; Personal Protective Equipment; and Safety Inspection.

The Cooperative looks forward to an organized, safe, and non-hazardous workplace for all its personnel as what was said in the seminar, "Every worker has the right to a safe and healthy workplace!"

Likewise, nearby barangays and agencies can also use the gymnasium as part of our Corporate Social Responsibility activities.

The following agenda were also thoroughly discussed by OIC-General Manager, Ms. Blandina Y. Madamba: 1.) Presentation of First Quarter Performance/Benefits given to Member-Consumer-Owners; and 2.) Collective Bargaining Agreement (CBA).

She emphasized that as early as the first quarter of year 2017, the Cooperative already showed positive remarks in its operations and has also presented the Corporate Social Responsibility (CSR) Programs of the Coop for the welfare of the member-consumerowners.

The second agendum holds a critical point as amendments of the CBA was laid out before the General Assembly— a first in the history of CAGELCO II. The CBA was last ratified in year 2010 and considering that its effectivity only lasts for five (5) years, proposals were made to benefit the employees to ensure that they remain dedicated and focused in their respective functions. Ms. Madamba acknowledged that the exemplary performance of CAGELCO II is to be attributed to the efforts and works of its human resource.

In order to confirm the amendments made, plurality of votes of the General Assembly during the AGMA was called. Dir. Castillejos pushed a motion for votation and remarkable show of hands was seen indicating the public's approval and support to the agendum. Likewise, Labor Union president, Ms. Suzette Vallangca, humbly requested that the Signing of the approved Collective Bargaining Agreement be made in front of the member-consumer-owners, which the Board of Directors has certainly accorded. Such signing is another milestone for the Cooperative.

CAGELCO II conducts Brigada Eskwela 2017

In cooperation with Department of Education's (DepEd) Brigada Eskwela 2017, CAGELCO II successfully conducted its Kuryente-Check in THIRTY-ONE (31) schools in its coverage area who were given free electrical repair of their classrooms to ensure safe and reliable electric service before the school year starts.

The said activity aimed to promote electrical safety awareness to provide

a conducive learning and working environment for the students as well as the teachers.

With the theme, "Isang DepEd, Isang Pamayanan, Isang Bayanihan, Para sa Handa at Ligtas na Paaralan", this yearly activity is part of the Coop's networking activities to strengthen linkages with the Education Sector as partners towards community development.



Financial Report

As of June 30 of this year, the Cooperative's Collection Efficiency (CE) is pegged at 101.06% which is higher than that of last year's CE at 98.72%.

The increase in CE performance is attributed to the on-time payment of powerbills from our member-consumer-owners.

What composes CAGELCO II's Power Bill?

PASS-THROUGH CHARGES

These are charges that CAGELCO II collects and remits to respective agencies and offices such as the following:

- 1. GENERATION Power Suppliers (GN Power, WESM)
- 2. TRANSMISSION National Grid Corporation of the Philippines (NGCP)
- 3. TAXES, SYSTEM LOSS, SUBSIDIES, PSALM/TRANSCO-Government Offices and Government Owned and Controlled Corporations (GOCC)



The EC-CAPEX/OPEX Charge is the only rate component that CAGELCO II collects and utilizes for the Coop's operations and programs. It only covers an average of 22% in the power bill while the Generation Charge covers the largest share of the electric bill at 45%.

Technical Report



System Loss reduction activities were given the outmost attention for the second quarter of this year which resulted to 12.40%, thus achieving a 0.35% lower than last year.

The replacement of Overcurrent Relays (OCR) at Magapit Substation and repair of other technical equipment such as Oil Circuit Breaker and SF6 Gas Circuit Breaker contributed in lowering SL and help enhanced power reliability.

The Cooperative also installed an additional Automatic

Voltage Regulator (AVR) at Dibalio, Claveria to improve the EC's voltage delivery to address the problem of voltage fluctuation in the coverage area. Also part of technical accomplishment is the energization of a 1.5 MVA Exclusive Connection of NOVO Mall-Savemore at Aparri, Cagayan.


